SUBJECT: UPDATED RATE SCHEDULES FOR COMMUNITY CARE FACILITIES
EFFECTIVE JANUARY 1, 2023 (MINIMUM WAGE INCREASE)

In the minimum wage increase letter dated December 19, 2022, rates for Community Care Facilities did not include an adjustment for the California minimum wage effective January 1, 2023. The updated rate schedules including the minimum wage adjustment effective January 1, 2023, can be found here. Regional centers must notify affected service providers of this change, update their rate tables and process retroactive rate increases accordingly.
