RE: Request for the development of an Adult Day Program for Individuals with Developmental Disabilities and Behavioral Challenges in Butte County.

Far Northern Regional Center (FNRC) is a private nonprofit organization under contract with the California Department of Developmental Services (DDS). FNRC is part of a statewide network of 21 Regional Centers responsible for the coordination and development of services to meet the needs of people with developmental disabilities in Shasta, Butte, Tehama, Siskiyou, Modoc, Trinity, Glenn, Lassen and Plumas Counties.

Far Northern Regional Center (FNRC) is seeking a provider to develop and implement a site base Adult Day Program in Butte County to support a growing number of individuals who demonstrate behavior deficits requiring direct support. The program must have the capacity to support up to twenty-five (25) individuals who require behavior management services in a program environment. Day program needs to focus around community integration and behavioral management support. The program will have direct and clinical support staff to assist clients with mental health and behavioral support needs. The program shall provide opportunities for individuals to be fully integrated in community events and allow individuals to seek activities and supports that are based on the individual's needs and preferences to engage in a full and meaningful life.

The program must be able to provide individualized and small group activities to individuals with a wide range of interest, preferences, and needs, which requires knowledge of local resources and how to assist individuals in accessing community resources they need and desire. The program should develop activities designed to build as much independence as possible for each unique individual. Individuals referred to program will require behavioral management support services for disruptive social behaviors. Behaviors may include property destruction, aggressive and/or self injurious behaviors, display of inappropriate social behaviors, potential assaultive behavior and person hygiene concerns. Individuals attending the program may require some type of behavioral intervention support services. The program needs to address transportation and provide adequate staffing ratios for participants.

Supports may include the usage of technology to connect targeted population to programming and community resources. Supports should include community activities that can be accessed by individuals to the same degree of access as individuals without a disability. The program should support individuals in a wide variety of community settings. Supports can be offered full and part-time to meet the needs and choice of individual clients. Service hours can be flexible to facilitate consumer access to community and peer events and activities.

Prospective vendor must have at least a minimum of 3 years experience in providing innovative services to individuals with developmental disabilities. The program will need to have sufficient number of competent trained staff who have experience in developing behavioral management plans and general knowledge in implementation of regulations for day program operation. Preference will be given to the most qualified applicant who intends to seek additional training and consultation, and has a willingness to collaborate with FNRC in meeting each individuals support needs.

Start up funds are available for this project through the Community Placement Plan (CPP) up to \$100,000.00. The on-going rate, which will be configured at the development phase, for program support will be subject to the statewide median rate structure. The selected applicant must meet vendorization requirements set by Department of Developmental Services as identified in Title 17 California Code of Regulations.

All interested parties are required to submit a proposal to FNRC. The proposal must include:

1. A cover page listing the applicant's name, address, phone number, name of person preparing the proposal if other than the applicant.
2. A description of applicant's education, experience related to the field of developmental disabilities and similar projects, and ability to complete the project.
3. Description of applicant's purpose/intention in operating the proposed service to be delivered, including meeting requirements for Home and Community –Based Services (HCBS)
4. Budget for start up cost, showing realistic costs of operating such program as required by this proposal. The budget will be used to support a contractual agreement for program development if applicant is selected.
5. Please include a generalized on-going operating budget cost for program operation. The FINAL on-going rate, which will be configured at the development phase, for program support will be subject to the statewide median rate structure.
6. A statement of applicant's goals and expected outcomes in providing client programming support services as it relates to day program services.
7. Transportation plan for programming services.
8. A description of how applicant will assess the level of support required to meet lifestyle preferences of the people served.
9. A statement of how applicant will plan for staff stability and training.
10. Information on how applicant will address the issues of equity and diversity. Applicant must include a statement of applicant's plan to support a diverse population, culturally and linguistic.

Please submit a hardcopy proposal, **the original plus five (5) copies**, to Far Northern Regional Center. All proposals received by the deadline will be reviewed and scored by evaluators selected by FNRC. Applicants who meet the proposal criteria may be invited to participate in an interview process.
